Release and Waiver of Liability

Acknowledgment that Horse Sports are a Dangerous Activity

In consideration for being permitted to participate in any way in horse sports activities and in particular on the grounds of Adelaide Northern Horse Riding and on public riding trails in the local area, I the undersigned, understand, acknowledge and accept that: **Horse sports are a dangerous activity and horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt.**

There is a significant risk that **INJURY** or **DEATH** may result from horse sport activities at this and other grounds. I knowingly and freely assume all risks, both known and unknown, even if arising from the negligence of Adelaide Northern Horse Riding, or any nominated event organiser associated with Adelaide Northern Horse Riding (hereafter referred to as the "Releasees") or others and I voluntarily PARTICIPATE at MY OWN RISK and assume sole responsibility for any injury, death or property damage I may suffer that arises from my participation in horse sport activities.

I understand and acknowledge the dangers associated with the consumption of alcohol or any mind altering drugs before and during the activity and I take full responsibility for any injury, loss or damage associated with their consumption. I agree not to drink alcohol or take drugs prohibited by Law before or during my participation in horse sports at these grounds and on public riding trails in the local area.

I agree to follow the directions of any official of Adelaide Northern Horse Riding.

I understand that any non-compliance may result in injury, death and/or permanent disability and I agree to indemnify the Releasees against all claims made by any person as a result of my failure to comply.

I agree to wear a helmet at all times whilst participating in the sport where this is required.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless and agree not to sue Adelaide Northern Horse Riding and or any event organiser, their officers, officials, volunteers, coaches, agents and/or employees, other participants, sponsoring agencies, sponsors, state bodies, affiliated clubs and if applicable, owners and lessor's of premises used to conduct the activities (all of whom are referred to as "Releasees") with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the releases or otherwise.

Effect of this document:

I have had sufficient opportunity to read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without inducement of any kind.

I understand that my signature to this document constitutes a complete and unconditional release of all liability of the Releasees, to the greatest extent allowed by law in the event of me and/or the children under my care, suffering injury or death.

For Participants of Minority Age (Under 18)

This is to certify that I, as a parent/guardian with legal responsibility for the participants, acknowledge, understand and accept all of the above and consent and agree to his/her release as provided above of all the Releasees, and, for myself, my heirs, assigns, and next of kin, I release and agree to indemnify and hold harmless the Releasees from any and all liabilities arising from my minor child's involvement or participation in horse sport activities and in particular, Adelaide Northern Horse Riding, even if arising from the negligence of the Releasees.
